## GENERAL RULES AND BEHAVIOR POLICY

- Gr8r Gaming sets out to host a safe and competitive environment inside the Gaming Lounge and during Esports tournaments.
- Guests are expected to observe the rights of other guests and staff members.
- Our behavior policy is in place to protect the rights and safety of our guests, staff members, as well as our equipment, facilities, and property.
- Disruptive Behavior is generally defined as “any guest behavior that interferes with the normal operation of Gr8r Gaming activities or which interferes with another guest’s ability to participate in Gr8r Gaming activities.”
- Guests who are excessively causing disruptive behavior may be required to leave the premises and, if a tournament is ongoing, forfeit their matches.
- Although we have house accounts for each console, guests may sign into their own Xbox Live or PlayStation Plus accounts. Gr8r Gaming is NOT responsible if any guest forgets to delete their account before leaving their station.
- No loitering inside the premises will be permitted. Anyone caught vandalizing Gr8r Gaming property will be prosecuted to the fullest extent of the law.
- Guests are expected to have reviewed all policies regarding Liability, Assumption of Risk, and Publicity Release prior to playing in the Game Lounge. All Policies and Rules are available at [www.Gr8rGaming.com](http://www.Gr8rGaming.com)

The following types of disruptive behavior are example of what will not be tolerated:

1. Any behavior that endangers the safety or health of others.
2. Violation of any local, state, or federal law.
3. Vandalism or deliberate destruction of equipment/property.
4. Theft of Gr8r Gaming property or the personal property of other guests and staff.
5. Use of abusive or intimidating profanity or obscene gestures to guests or staff members.
6. Behavior or language that is willfully harassing, racially insensitive, or threatening to another person.
7. Use of alcohol, cigarettes, or illegal substances on the property.
8. Eating or drinking beverages purchased outside of Gr8r Gaming and/or being consumed at a Gaming Station.
9. Other kinds of behavior deemed inappropriate in the opinion of designated staff members.

## MINOR POLICY

- A Minor is defined as “any child under the age of 18.”
- Any Minor under the age of 17 that is requesting to play a game rated M for Mature must have a parent or guardian sign a consent form before they will be allowed to play M rated games.
- Parents of minors aged 8 years & under MUST accompany their child at ALL times.
- We are not responsible if your child leaves the premises.
